Dear Residents & Family Members,

We are committed to keeping you well informed of updates and changes with the impact of COVID-19 on our Friends House community. Please see the chart below for our current numbers related to positive COVID-19 cases for both residents and staff. These numbers are reflective from the very start of the pandemic. Since the last update and within the last 24 hours we have reported 3 positive staff cases to the local health department. One of the positive cases is for a staff member that works at Friends House on an as needed basis and has not worked at Friends House since the test, however this individual tested positive at their other place of employment and we are obligated to report them in our numbers as well.

We continue to test staff twice a week and residents once per week. Additionally, we screen all staff before they report for their shift and screen residents daily for symptoms of COVID-19. We act quickly when staff and/or residents test positive. They must be isolated for at least 10 days.

**Vaccine update:**

Our first vaccination clinic date will be Monday, January 18, 2021. This will be for residents and staff on the health care units. The vaccination is comprised of a series of two shots, with the second shot scheduled for February 8, 2021. Our last scheduled clinic visit is March 1, 2021.

We will not directly receive a supply of the vaccination. Rather, CVS pharmacy will bring the vaccine to Friends House and administer it during these scheduled clinic days. Residents and staff must complete consent forms and provide copies of insurance cards in advance of the CVS team clinic. Over the course of the next couple of days we will ascertain the residents and staff who choose to receive the COVID-19 vaccination.

The vaccination is available at no cost to residents and staff. CVS will charge each individual's insurance plan for any clinic or vaccination administrative cost. These

vaccinations are for residents who reside in the Health Care buildings and Friends House staff.

More information about the vaccination will follow as we receive it. Please check the Friends House website often for updates.

We will continue window visits at least for the next two weeks. If you would like to schedule a window visit, please call the front desk of Stabler Hall during regular business hours to schedule a time, or feel free to request a Skype or FaceTime call. The number is 301-924-7531. If you would like to schedule a window visit or FaceTime call for a resident who lives in Haviland Hall (Assisted Living), please call 301-924-7518.
