Dear Residents & Family Members,

We are committed to keeping you informed of updates and changes in the impact of COVID-19 on our Friends House community. Please see the chart below for our current numbers related to positive COVID-19 cases for both residents and staff. These numbers are reflective from the very start of the pandemic. There has been one additional positive case since yesterday's update.

We are following the CDC and state regulations for staff who test positive. These staff members are self-isolating at home for a period of no less than 10 days. They are allowed to return to work if at least 10 days have passed since symptoms first appeared; at least 24 hours have passed since their last fever without the use of fever-reducing medications; and symptoms (e.g., cough, shortness of breath) have improved. No one will be allowed back unless these criteria have been met.

At this time, we will maintain our regular Friday, Saturday, and Sunday visiting schedule. However, all visits will be outside visits, <u>regardless of the weather</u>. If the weather is not conducive for residents to safely visit outside, then we reserve the right to convert the visit to a window visit at the scheduled time so that residents may stay safely indoors. This week's visits will be scheduled from 2:00 pm to 5:00 pm. The same guidelines (no food or other items masks on, social distancing), as before are in effect. The visits in December and January will be the same days but will move to 1:00 pm to 4:00 pm in order to have the benefit of sunlight if we have outside visits.

When we go back to indoor visits, they will only be allowed to visitors who can show proof of a negative COVID-19 test within 72 hours of the scheduled indoor visit. Otherwise, visitors will not be allowed in the building.

We hope everyone who is able to is enjoying window visits with your loved one. If you would like to have a window visit on Thanksgiving Day, please call the front desk of Stabler Hall during regular business hours to schedule a time, or feel free to request a Skype or FaceTime call. The number is 301-924-7531. If you would like to

schedule a window visit or FaceTime call for a resident who lives in Haviland Hall (Assisted Living), please call 301-924-7518.

The added cost of testing and additional personal protective equipment has placed a heavy burden on communities like Friends House. Some have asked how they can help.
